Liability Waiver and Release: This form must be completed prior to participating in any and all Nerf 4 K activities

As Consideration for being allowed to participate in any Nerf 4 K activities, the undersigned, on his or her behalf, and on the behalf of the Participant(s) identified below, acknowledges, understands, and agrees to the following:

1. I represent that I am the parent or legal guardian of the Participant(s) named below or I have obtained permission from the parent/legal guardian of the Participant(s) named below to execute this agreement on their behalf.
2. I acknowledge and understand that there are known and unknown risks associated with participation in Nerf 4 K activities and the use of the Nerf equipment and inflatable equipment. I consent and fully understand that:
 - The events are physically and mentally intense and may require extreme exertion to play
 - The possibility of injury to myself and others exists.
 - That indoor or outdoor activities carry the danger of trips, slips, and other common physical injuries or hazards.
3. I, for myself and the Participant(s) named, understand that the following conditions must be adhered to and failing to comply with any rules will result in removal from the Nerf 4 K activities, with no refunds
 - I will always follow the verbal and written instructions of my Nerf 4K referee.
 - I will not use foul or inappropriate language
 - I will play fair and respect other players
 - I will not consume any alcohol prior to participating in any Nerf 4 K activity
 - I will not climb on any of the inflatables or other structures within the Nerf gaming arena.
4. I for myself and participants, hereby discharge from any claims and liabilities, without limitation that I may have against Nerf 4 K, the owners of the property on which the events are held and any other players who might be injured.
5. Any controversy, dispute, or claim arising out of or related to this Agreement, which the parties are unable to resolve by mutual agreement, shall be settled exclusively by submission by either party of the controversy, claim or dispute to binding arbitration; said arbitration to take place exclusively before a single arbitrator located within 25 miles of the Event location and in accordance with the rules of the American Arbitration Association then in effect.
6. I give my permission for Nerf 4 K to use any pictures and video I may appear in for their use in marketing, social media or other means.

By signing this Waiver and Release, I assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with Nerf 4 K activities. I agree that the Participant(s) named, and I shall comply with all stated and customary terms, rules, and verbal instructions as conditions for participation in any Nerf 4 K activity.
